This amendment is by and between the State of Minnesota, through its Board of Water and Soil Resources, and Pennington County, 101 Main Ave N Thief River Falls Minnesota 56701.

Recitals

1. The State has a Grant Agreement with the Grantee identified as the FY 2014 & 2015 Natural Resources Block Grant Agreement, PO #3000003996, for the 2014 and 2015 Septic Treatment Systems Upgrade grants, P14-4972 and P15-9959.
2. The County requests an extension to allow time to further advertise the program, secure eligible applicants, and complete additional SSTS upgrades.
3. The State and County are willing to amend the Original Contract as stated below.

Contract Amendment

REVISION 1. 1 Term of Grant Agreement

1.3 *"Expiration date:"* is amended as follows:

REVISION 2. 2 Grantee's Duties

2.2.3 is amended as follows:

Except as amended herein, the terms and conditions of the Original Grant Agreement remain in full force and effect.
